Stepwise Planning Process

1. Get organized
2. Identify a full range of possible actions
3. Review and refine inventory & forecast of GHG emissions
4. Identify initial priorities for analysis
5. Develop straw policy design proposals
6. Quantify initial GHG reductions and costs/savings
7. Fully develop policy option templates
8. Develop alternatives to address barriers as needed
9. Aggregate and integrate results
10. Finalize and report recommendations

Step 2: Identify a Full Range of Possible Actions
