Stepwise Planning Process

1. Get organized
2. Identify a full range of possible actions
3. Review and refine inventory & forecast of emissions
4. Identify initial priorities for analysis
5. Develop straw policy design proposals
6. Quantify initial GHG reductions and costs/savings
7. Fully develop policy option templates
8. Develop alternatives to address barriers as needed
9. Aggregate and integrate results
10. Finalize and report recommendations

Step 4: Identify Initial Priorities for Analysis

Preliminary Tier 1 Priorities

- Advanced Fossil Fuel Technology (e.g. IGCC, CCSR, Advanced Pulverized Coal, CFB) Incentives, Support or Requirements (*ES-4.1*)
- New Nuclear Capacity (*ES-4.2*) and Relicensing/Up-rating Existing Nuclear Power (*ES-4.3*)
- Transmission System Upgrading (*ES-4.2*); Reduction of Transmission and Distribution Line Losses (*ES-7.2*); and Smart Grid Systems (*ES-7.8*)
- Renewable Portfolio Standard (*ES-2.1*); Energy Efficiency Resource Portfolio Standard (*ES-3.1*); Utility Energy Efficiency Incentives or Other Barrier Removal (*ES-3.2*); and Consumer Energy Efficiency Incentives or Other Barrier Removal (*ES-3.3*)

Preliminary Tier 1 Priorities (con't)

- CCSR Incentives, Requirements and/or Enabling Policies (Administration, Regulation, Liability, Incentives) (*ES-6.1*) and R&D for CCSR (*ES-6.2*)
- Technology Focused Initiatives (Biomass Co-Firing, Energy Storage for Renewable Energy Generation, Fuel Cells, etc.), including Grant Programs (*ES-2.7*) and Research and Development for Renewable Technologies (*ES-2.8*)
- Technology Research and Development (*ES-1.6*)
- Green Power Purchases and Marketing (*ES-2.4*) and General Education to Public on Energy Supply Options (*ES-8.1*)

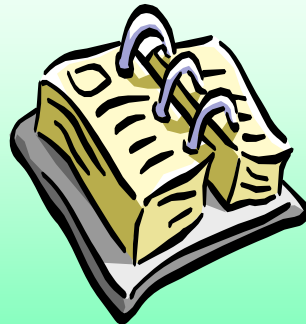
