Stepwise Planning Process

1. Get organized
2. Identify a full range of possible actions
3. Review and refine inventory & forecast of emissions
4. Identify initial priorities for analysis
5. Develop straw policy design proposals
6. Quantify initial GHG reductions and costs/savings
7. Fully develop policy option templates
8. Develop alternatives to address barriers as needed
9. Aggregate and integrate results
10. Finalize and report recommendations

Identify Initial Priorities for Analysis

- Overall, the KEEP will identify 50 priorities for analysis
- This group will identify three tiers of priorities
 - Tier 1 will be advanced for consideration by KEEP
 - Tier 2 will not be advanced, but will be available for KEEP members to review
 - Tier 3 will not be advanced

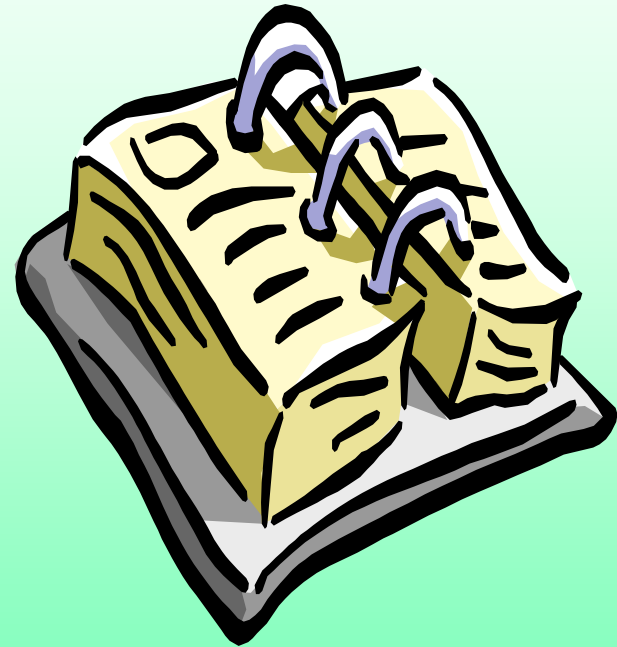

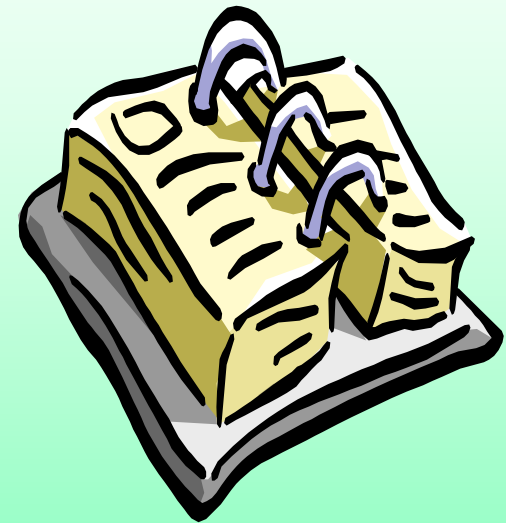
